PAYMENT AND CANCELLATION SCHEDULE: A \$500.00 deposit is required at the time of booking; \$200 is non-refundable after 15 days. Final tour payment is due by April 20.

The total cost of this tour from Asheville NC is \$2990. The tour begins the morning we arrive in Munich Germany. Each tour member is responsible for his or her own airfare from hometown to Munich; the air fare is in addition to the tour cost above. BrenCase Adventures will have a group of discounted seats available from Asheville, and can also assist with discounted air fare from other cities if Asheville is not convenient.

TRAVEL DOCUMENTS AND FORM OF PAYMENT: The traveler is responsible for obtaining a valid passport. If you have a passport, it should not expire within six months of the tour return date. No visa will be required.

Payment for the tour may be made by cash, check, money order, credit card or PayPal. If a credit card or PayPal is used, a 3% charge will be added to each payment. Once registered, a refund request will be considered on an individual basis, depending on circumstances. Failure to cancel (in writing) 30 days prior to departure or show up for departure may result in 100% of tour price being forfeited by traveler.

BAGGAGE ALLOWANCE: Travelers are allowed one checked bag per person not to exceed 50 pounds and 62 linear inches. You also are allowed one carry-on bag not to exceed 45 linear inches, and a personal item such as a purse, camera case or laptop computer case. Because of the extensive train travel during the second half of the tour, you are strongly encouraged to travel with luggage you can handle easily.
